## REGISTRATION NOTES

### < HOLDING SPOTS

Please note that spots WILL NOT be held without deposits and completed proper paperwork.

### < COMPLETED APPLICATION

Upon return of the completed application form and payment, a receipt will be sent to you in late October. For those who register between July and October 2011, you will receive an email or phone call to confirm your registration before the receipt is sent at the end of October.

### < DEPOSIT & FINAL PAYMENT

Application forms must be accompanied by either the full payment OR by the total deposit together with a post-dated cheque for the balance of the fees. **Deposit is \$350 per week or \$75 for WEEnonah and is due upon registration.** All balances are due by April 02, 2012.

### < REFUND POLICY

UP TO JANUARY 31, 2012: Full refund of all fees less a \$25/week cancellation fee (per camper).

FEBRUARY 1 - APRIL 02, 2012: Full refund of all fees less a \$100/week cancellation fee (per camper).

AFTER APRIL 02, 2012: All fees are non-refundable.

There will be no refund made for any camper leaving camp during any Camp Period, including for reasons of homesickness. In the case of illness or injury incurred at Camp, a credit for the following season will be given. Also, there will be no refund or reduction of fees for campers arriving late or leaving early.  
*Please allow 3 weeks to process all refund requests.*

## CREDITS/AMOUNTS OUTSTANDING

Some returning families do have small credits or amounts outstanding on their camp account(s) from past years. We will not process amounts of \$5.00 or less (either credits owed or amounts outstanding). If an amount greater than \$5.00 is outstanding, please send that along to our Burlington Office as soon as possible. Account credits of \$5.00 or more may be applied to fees or to other Camp expenses prior to Camp (laundry, transportation, out trips, etc.). Refund cheques can also be requested through the Camp Office.

## CABINMATE REQUESTS

Please note that cabin mate requests are honoured for those campers attending the SAME amount of time.
